2 WAYS TO APPLY:

1. THROUGH AN EMPLOYER ONLINE (<https://nullaostalavoro.dlci.interno.it>)
2. BY YOUR OWN IN A POST OFFICE (Sportello Amico)

ONLY FOR WORK IN AGRICULTURE, FISHING, FARMING AND RELATED ACTIVITIES (write us for more info) AND DOMESTIC WORK.

AUGUST 15H 2020

TO APPLY WITH YOUR EMPLOYER YOU DON'T NEED TO SIGN A CONTRACT BUT YOU NEED TO FIND AN EMPLOYER WILLING TO APPLY FOR YOU ONLINE.

REGOLARIZZAZIONE 2020 (SANATORIA)

APPLICATION WITH THE EMPLOYER

1. Go on the website <https://nullaostalavoro.dlci.interno.it/> authenticate with SPID
2. Upload all the required documents.
3. Print your receipt showing you applied. This will be needed to proof your status and to work.
4. If the application is accepted, you will be called in Prefettura to sign the residence contract;
5. After you sign the contract in Prefettura, you will be given a paper to apply for your residency permit. The length of the permit will depend on the length of the job contract, and in any case, it will not be longer than 2 years.

REGOLARIZZAZIONE 2020 (SANATORIA)

YOU CAN APPLY WITH THE EMPLOYER IF YOU ARE ALREADY WORKING WITHOUT CONTRACT OR YOU WANT TO SIGN A NEW CONTRACT AND:

1. You are in Italy before 8 of March 2020;
2. You have not left Italy after 8 of March 2020;
3. You have not been condemned for serious crimes (contact us for more info)

YOUR EMPLOYER TO APPLY:

1. Was not condemned for serious crimes
(labour exploitation, prostitution, trafficking, etc.)
2. The income of the employer should not be lower than:
 - 30.000 € per year for agriculture, fishing, farming, etc.
 - 20.000 € (for only 1 worker in the family) or 27.000 € (for more than one worker)euros per year for domestic work.
 - If the employer is not self-sufficient, the income will not be taken into account.

WHICH DOCUMENTS DO YOU NEED TO APPLY WITH THE EMPLOYER?

- a. Employer personal data;
- b. Worker personal data;
- c. Data of the workers with a valid document (passport, identity declaration from the embassy) or expired residency permit (but when you will go to Prefettura you will need to show a valid document);
- d. Proof of your presence in Italy before 8 of March2020;
- e. Residence contract proposal;
- f. Proof of employer's income;
- g. Declaration of retribution;
- h. Length of the job contract;
- i. Receipt of 500€ payment (Model F24 (REDT 2020))
- j. Marca da bollo,16 €.

REGOLARIZZAZIONE 2020 (SANATORIA)

**IF YOU CANNOT FIND AN EMPLOYER WHO
MAKE THE REQUEST YOURSELFAT, YOU CAN
APPLY YOURSELFAT POSTE (kit postale) IF :**

1. Your document expired after 31st October 2019;
 2. You have not left Italy after 8 March 2020;
 3. You have already worked in agriculture, fishing, farming or domestic work before 31 October 2019.
- IN THIS WAY YOU CAN OBTAIN A TEMPORARY PERMIT (FOR SIX MONTHS) WHICH WILL THEN BE CONVERTED INTO WORKING PERMIT WHEN YOU FIND JOB CONTRACT IN ONE OF THE 3 SECTORS FORESEEN BY SANATORIA.

REGOLARIZZAZIONE 2020 (SANATORIA)

WHICH DOCUMENTS DO YOU NEED TO APPLY AT POSTE (kit postale)?

- a. Copy of passport or any other equivalent document, such as declaration of identity released by your embassy / consulate.
- b. Copy of your expired residency permit or of the police report in case you lost it;
- c. Fiscal code;
- d. Proof of work before 31st October 2019;
- e. Proof of your address (for instance, self-declaration will be ok) ;
- f. Receipt of 130€ payment (Model F24 (REDT 2020));
- g. Marca da bollo, 16€.

REGOLARIZZAZIONE 2020 (SANATORIA)

SOME EXAMPLES OF DOCUMENTS ACCEPTED AS A PROOF OF YOUR WORK BEFORE 31 ST OCTOBER 2019:

- Certificate released by the employmentcentre (C2 work history) ;
- Job contract;
- Copy of your bank account with you salary payment; - Copy of cheque;
- Copy of tax payments;
- Any kind of communication between you and your employer about the job, where it is possible to identify your identities.
